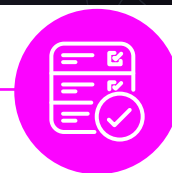

- **Funding Eligibility Assessment: Evaluate eligibility for platform-specific funding support:**
 - **GCP:** Development Acceleration Fund (DAF) and Professional Services Fund (PSF).
 - **AWS:** Marketplace funding programs for ISVs.
 - **Azure:** Co-sell incentives and marketplace development funds.
- **Solution Architecture Review:** Review product architecture to identify gaps and ensure it aligns with the technical requirements of the chosen platform, covering deployment models such as VM, Kubernetes, or SaaS.
- **Consumption & Revenue Projections:** Develop estimates tailored to the marketplace, considering small, medium, and large consumption scenarios.

Deliverable: Solution Assessment Report detailing funding eligibility, architecture gaps, and initial consumption projections for the selected platform.

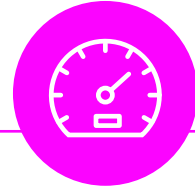
